## LIABILITY RELEASE

Therefore, in consideration of the opportunity to participate in the events, I do, hereby forever RELEASE, QUIT, and FOREVER DISCHARGE the Bismarck Horse Club, all of its committees, members, employees, agents, directors, and everyone else who is involved with these activities from any and all claims, actions, causes of actions, demands, rights, damages, costs, lawsuit services, expenses, compensation and anything else that I may ever sue for or could have sued for which I may incur on account of or in any way growing out of any and all known and unknown, foreseen, or unforeseen, bodily or personal injuries, and/or property damage, or the consequences thereof resulting from any accident, casualty, event, episode, or thing involving me and arising out of the activities or events.
